Dear Ms. Borgese:

Enclosed please find the registration certificates for Setters (English), MIRABELLE (USA) #1024593 and DORVAL (USA) #1024594.

It was noted from the applications for the above mentioned dogs that they were imported on the same date, presumably in a single shipment.

In this connection, we have attached a copy of an extract from our By-laws which makes it clear that when two (2) or more dogs of the same sex and breed are imported to Canada in a single shipment, then all dogs in the shipment must be tattoo marked in accordance with our tattoo regulations, before the dogs are actually exported to Canada. See enclosed brochure. Your applications indicated that the dogs were noseprinted for identification purposes.

However, in this instance the Registrar has authorized registration and the issuance of certificates, due to the fact that these females share a common lineage being littermates, but has instructed this office to draw your attention to the regulations in connection with any other dogs you may import to Canada where these regulations apply. Failure to comply with these regulations in the future WILL result in our refusal to register dogs imported to Canada under similar circumstances.

Dear Ms. Borgese:

We acknowledge receipt of your letter, enclosing a copy of correspondence received from the Canadian Kennel Club, indicating that they require the original AKC registration certificates for a male and two female English Setters registered with the American Kennel Club as Angus Mincio, SC-765576, Dorval, SE-981205, and Mirabelle, SE-981204.

A certificate for your male was issued and sent to you December 11, 1979. Certificates for your females were issued October 15, 1987, and mailed directly to you. It is those registration certificates that the Canadian Kennel Club is requesting in order to accomplish Canadian Kennel Club registration of the dogs, together with the enclosed certified pedigrees of three generations for each of the dogs.

Do you have the original AKC registration certificates for the dogs? These are certificates which are white with lavender trim border and show your name on the face as the owner of the dog. After CKC registration has been completed, they will return the AKC certificates to you, of course.

Should there be need for further correspondence, enclose this letter with yours.
