I am happy to be sending you, under separate cover, four copies of Popular Library's reissue of THE NYMPH AND THE LAMP, which they plan to publish on 18 March.

If you are keeping track of the reprint sale, I think that you might want the following information: when the \$500.00 advance paid on signing was entered in November, 1956, we thought that the price was going to be .35, so your share went through as 35,71½ copies @ .007 -- \$250.00; the price now turns out to be .50, so the \$250.00 actually covered 25,000 @ .01; the current payment of \$500.00 paid on publication in March will, of course, show as 25,000 @ .01, the total amount remaining the same. The royalty on .35 books, by the way, is .01½ on 150,000, then .021 and the royalty on .50 books is .02 on 150,000, then .03.

Mr. Joseph Consolino has passed your correspondence concerning THE NYMPH AND THE LAMP and TIDEFALL to me since I am in the Foreign Rights Department. At this time I shall attempt to explain the misunderstanding surrounding the new edition of your book THE NYMPH AND THE LAMP.

In your letter of April 4 you mention having received royalties on a new edition of the book printed in England. This is not an "English edition" as you said but rather a Dutch Readers Digest condensation which we arranged through Mr. Robert Harben, the London literary agent who originally arranged the Dutch language edition of NYMPH with Uitgeverij Born. The reason we felt in May of 1971 that we had the right to make this contract is that we believed that the German edition of THE NYMPH was still in print. This belief was based on reports of sales which we received from Zsolnay, the German publisher, for the years 1968, 1969 and 1970. You were not informed of these sales because they were so slight (six copies in 1968, three in 1969, three in 1970) and we do not report sales of so few copies to authors. We have no report of sales for the German edition for the years 1971 and 1972, so perhaps we were at fault in basing our decision on the sales reported in 1970. We are writing to ascertain the correct status of this edition.

If you agree with us that the contract with the Dutch Readers Digest was one within our rights to make, Little, Brown owes you the \$399.06 that was your portion of the \$576.07 we received (and you returned); \$189.38 for the June 1972 royalty period and \$120.96, the amount received since the June cut-off date. These royalty payments represent two-thirds of the monies received by Little, Brown for this edition.

If you do not feel that this is a fair resolution of this matter, Little, Brown is willing to forgo its right to monies accrued from the Readers Digest contract and credit you with the entire amount we have received. Mr. Thomas Raddall - page 2

If you would like all rights reverted on THE NYMPH AND THE LAMP and TIDEFALL, please write to Miss Mary Jane Higgins, Assistant to the Managing Editor, for a formal reversion letter.

We truly regret this misunderstanding and apologize for the inconvenience it has caused you. Thank you for your patience.
