

Dear Norman:

Herewith Elisabeth Mann Borgese's article for the Pacem in Maribus takeout. As you will appreciate Mary and I have had to perform some major surgery to get the mass of material from Malta into this compass. A full set of everything we have prepared for you has been rushed to Elisabeth in Italy. I do not expect any substantial changes, and I have warned her that the deadline is upon us and asked her to cable us here if any changes are required.

I realize this is a lot of wordage, but I hope you'll agree that urgency of the issue --- and the possibility of adding interest with the sidebar material --- justifies carrying it pretty much as is. The Nixon seabed proposal can only be understood in this context, and it hasn't been put together anywhere else.

We are, of course, anxious to attract as much attention as possible around the world while the Seabed Committee is still sitting in Geneva. Unless you object we'd like to offer the same material for publication (after your release date) in England, France, Germany, Italy and Japan. This would mean you have first U.S. magazine publication, and the Center retains all other rights. Any payments, incidentally, go to the Center's dwindling coffers.

Mary will phone you on Friday to discuss any problems that may arise.





The Five Pacem in Maribus Volumes

Later this month could the Center send the five volumes to somebody who will be doing a series of articles on the Malta Pacem in Maribus?

I have only one request for this so far and don't expect more than two or three more if that. But I would like to know the possibilities for publications with long closing dates where there is no problem of premature release. Here is the situation with the single request, which is not in this category.

Business International publishes a flock of high-level publications for business executives worldwide. They think Pacem in Maribus is important. They are sending to Malta for the whole conference William Barton, vice president and director of their Washington office. William Persen, executive vice president and editorial director, is himself doing and supervising a series of articles to start appearing in their various publications immediately after Malta. I have provided both of them with introductions to the five volumes. Barton will of course get the five volumes at Malta. But Persen has asked if he can have them by the end of this month to use as the basis for his articles. If this is all right with Santa Barbara, they should be sent to him directly with just a note saying "Mr. Haussamen of our New York office requested that we send you the enclosed five volumes of the Pacem in Maribus proceedings for a series of articles you are preparing for the publications of Business International." The attached letter from the managing editor of the University of Indiana Press is representative of the considerations we run into when we attempt to place for publication Center materials that have only a specialist or otherwise limited interest. Such arrangements are ruled out by the policy that anything we publish is expected to at least break even.

Dear Mrs. Borgese:

Your most interesting letter of August 13 arrived just as Mr. Perry was leaving for his vacation, and he has turned it over to me for reply. We fully appreciate the importance of the Pacem in Maribus material, and are only sorry that, as Mr. Ashnore informs us, publication of the meat of the thing has been contracted with Dodd Mead. We should have been nost interested in issuing this summary volume for wide distribution. We quite understand your desire to publish the entire corpus of papers, etc., which you have collected, and agree that this would be a great service to scholarship. Unfortunately the publication of seven rather technical volumes (you do not indicate their length), presumably mainly for a rether limited market of specialists, presents serious problems for a publisher, especially in these days of business sluap and financial stringency at this university. I doubt if the Press could take it on without the assurance of a pretty big subsidy, perhaps \$5,000 to \$10,000 per volume, some of which might be returnable if sales justified it. In addition, I don't believe we could get the books out before 1972 at the earliest and maybe later than that.

I don't think the Press can make a final decision in this matter until Mr. Perry returns, around September 15, but thought I should write you now about the present state of our thinking. We should not take it amiss if you wanted to get in touch with another publisher who may be in a better position than we are to meet your needs. On the other hand, if you see a good prospect of a substantial subsidy, that would of course change the picture.
