Thanks for your letter of November 26, which reached me with some delay.

Practically all my work on aduaculture has been covered by my book Seafarm. I have published a couple of minor articles since then, but, really nothing new. I do follow developments though, and there is a lot going on now here in Canada. I also have some new data on China.

I am happy to know you are doing a six hour program on the oceans. I am sure you are including ocean mining and energy from the oceans, such as OTEC. There are new and interesting technologies, especially in Germany, for desalination through OTEC-related, sun-energy re-inforced technologies. Such a plant has just been installed in Saudi Arabia.

I am going to Saudi Arabia in February, for a scientific cruise through the Red Sea, to study the metalliferous brines.
