# Challenge & Change

— A record enrolment, despite the reluctant imposition of sharply increased tuition and residence fees.

— A departure in student residences — Fenwick Place, now nearing completion with most of its apartment floors occupied.

— Long overcrowded in old buildings, Biology, Oceanography and Psychology have now breathing space in the Life Sciences Centre. Other new buildings in operation: The Arts Centre and the Central Services Building.

— A comprehensive, top-quality program in the arts — music, art, film and theatre, plus special events to mark the official opening of the Arts Centre in November.

— Administrative changes at the top: Dr. C. B. Stewart appointed Vice-President (Health Sciences); succeeded as Dean of Medicine, pro tem, by Dr. Lloyd Macpherson; Glen R. George, associate comptroller and business manager, now Controller; Ronald St. John Macdonald, to succeed the late Dean R. T. Donald as Dean of Law next summer, and Professor Murray Fraser now the first Associate Dean of Law.

— A one-year trial appointment of an ombudsman and assistant ombudsman.

— Continuation with what is expected to be a heavier load of the Dalhousie Legal Aid Service.

— Acquisition of a mobile dental clinic to facilitate the dental school's summer projects of taking dental care and treatment to selected 'dentally neglected' areas of the province.

— Inauguration of the Centre for Foreign Policy Studies, with top-flight experts on the staff and the seconding from the External Affairs Department of a senior foreign service officer.

— The birth of a faculty club — after years of hesitant talk — in the old Law building.

— More student projects in and for the community at large.

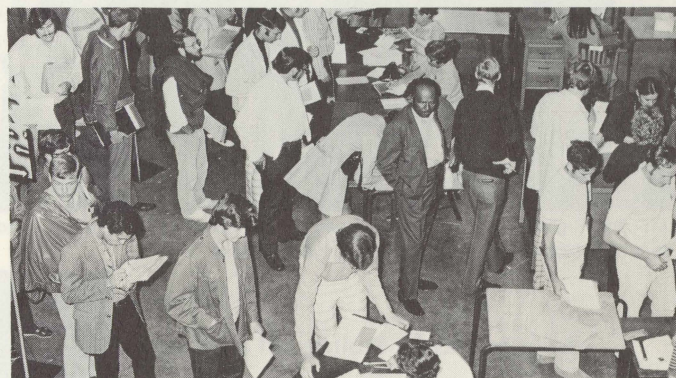
These are but some of the events and developments that will mark 1971-1972 as a significant year in the history of Dalhousie.

By September 26, the Registrar's Office had a head count of nearly 7,000 students for the 1971-1972 term. This seems to clearly indicate that the demand for university places is not decreasing, notwithstanding what some outsiders are saying.

There is no doubt that it will be difficult to meet this increasing demand, which is likely to continue for the next few years. This year, for instance, with possibly more than 1,000 students more than last year, the teaching staff has not been increased because of unprecedented budget cutbacks caused by lack of operating funds.

But at least this year there are more and better facilities. The common classrooms of the Life Sciences Centre will alleviate some of the pressure on classroom space.

For the first time the Music and Theatre departments will have adequate teaching facilities all under one roof in the Arts Centre, which also houses the Art Gallery. The Arts Centre will also make its mark, particularly in the Rebecca Cohn Auditorium and the Art Gallery, with programs which are open to both the university community and the community at large. Some details of the extra-curricular program in the Arts Centre will be found elsewhere in this Alumni News.



The acquisition of Fenwick Place, the 33 story apartment building which was left unfinished when the general contractor went bankrupt, increased the number of student living spaces in university buildings to 2,070. These have all been booked and there is a waiting list of over 400 for the various halls of residence.

But more important than the numbers involved, says John W. Graham, general manager of the Student Union, Fenwick Place provides students with a new dimension in living. Far removed from the sameness of the single and double rooms of the conventional on-campus residences. Fenwick's apartment-type accommodation, with landlord-tenant relationship, means that the student can choose from a variety of designs in which to live and can probably acquire more of a sense of responsibility and maturity than in the somewhat regimented life-style of the conventional residence.

While there is no doubt that Fenwick Place has relieved much of the pressure on residence accommodation, the problem of housing married students with children still exists. This group makes up about 24% of the student body.

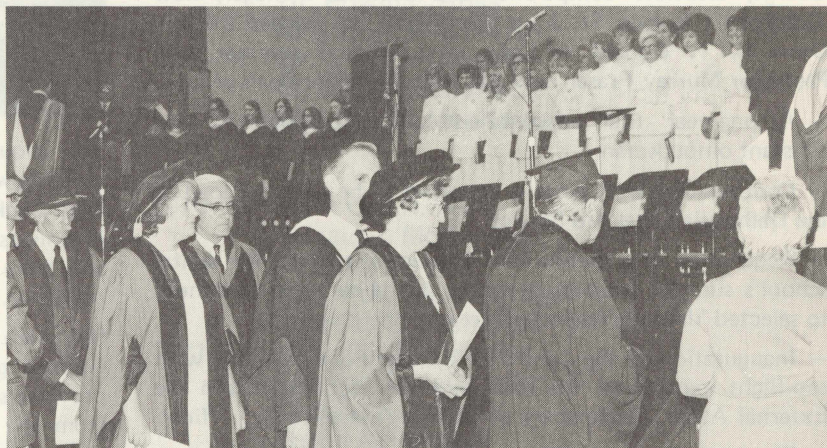
On the financial side of the university, tuition and residence fees were increased across the board by \$100, a difficult and reluctant decision taken by the Board of Governors but one which, despite the general state of the economy, does not appear to have adversely affected enrolment. No increases for 1972-73 are envisaged, but it is not known what the provincial government, through the University Grants Committee, may do next year in terms of operating grants. Meanwhile, budgets for the year beginning July, 1972, are now being prepared and will be submitted to the University Grants Committee in October.

## Resource rôle of alumni

The Queen Mother was guest of honor at a luncheon given Oct. 20 by the Dalhousie Society of Great Britain, at which Dr. Henry Hicks, president of the Halifax university, announced that President Tito of Yugoslavia will be given an honorary degree at Dalhousie during his Canadian visit.

Dr. Hicks also said that an honorary degree will be bestowed on veteran writer and traveller Sir Fitzroy Maclean, who fought with Tito's partisans during the Second World War.

The Queen Mother, wearing a blue dress with blue petal-trimmed hat and diamond maple leaf brooch, holds an honorary degree from Dalhousie. So does Lord Goodman, British government emissary in attempts to settle the Rhodesian crisis, who was another of the head table guests.

The Earl of Dalhousie, whose family gave their name to the university, presided at the luncheon for 115 guests in the Royal Commonwealth Society building near Trafalgar Square.

Canadian High Commissioner J. H. Warren and five provincial agents-general with their wives were also among head table guests.

The Dalhousie Society has about 100 members in Britain. Its last such luncheon was held three years ago.

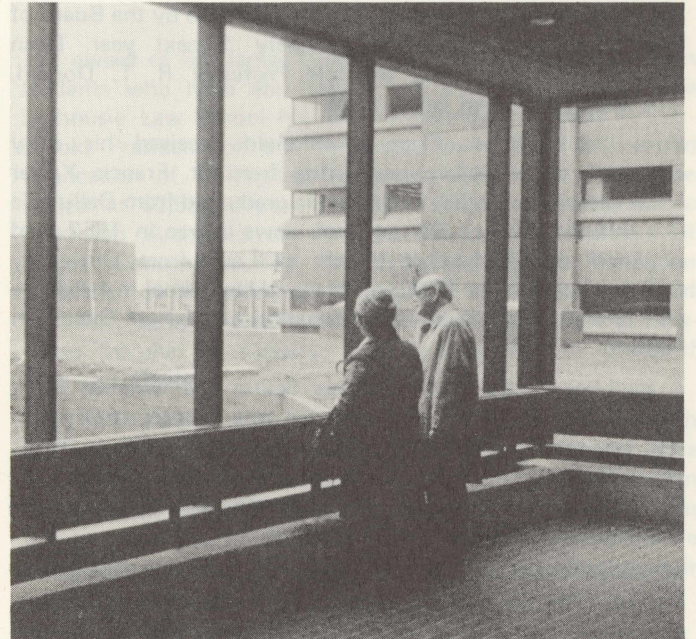
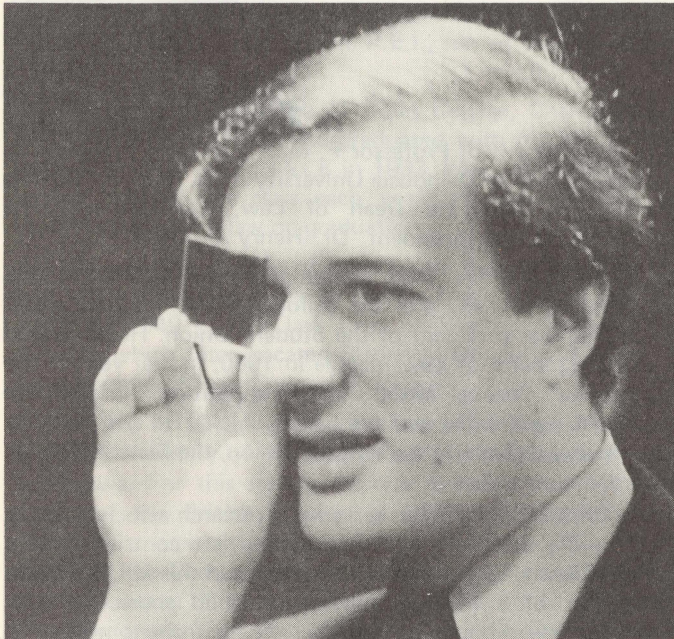

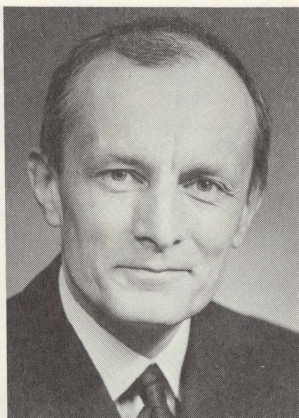

Ronald St. John Macdonald, QC, Dean of the Faculty of Law at the University of Toronto since 1967, and an outstanding contributor to legal literature in Canada, has been appointed Dean of Law at Dalhousie University, Dr. Henry D. Hicks, the president, announced yesterday.

Dr. Hicks said that the appointment, approved by the Board of Governors, would be effective July 1 next year. Dean Macdonald will succeed the late Professor R. T. Donald, who had been Dean since 1969.

Born in Montreal, Dean Macdonald received his early education there before graduating from St. Francis Xavier University with his BA in 1949. He graduated from Dalhousie law school with his Bachelor of Laws degree in 1952, and obtained the degrees of Master of Laws from University College, London, in 1954 and Harvard law school in 1955. He also received his Diploma in International Law from Geneva in 1955.

A member of the Bars of Nova Scotia and Ontario, Dean Macdonald began his teaching career as a lecturer at Osgoode Hall law school, Toronto, a post he held from 1955 to 1959. He joined the University of Western Ontario as professor of law in 1959 and two years later became Dean of Law at the University of Toronto.

In 1965 he was a visiting professor of law at El Colegio de Mexico. The same year he was a member of the Canadian delegation to the 20th session of the United Nations General Assembly, and again in 1966; at those sessions he was the Canadian representative and rapporteur of the Third Committee (human rights), and in 1966 was vice-chairman of the committee.

In 1968 Dean Macdonald was a delegate to the United Nations International Conference on Human Rights, in Teheran, Iran.

Chairman of the federal government's Canada Pension Plan advisory committee since 1967, Dean Macdonald has also been a senior fellow of Massey College since 1969, and was a special adviser to the Canadian delegation to the United Nations in 1970 and 1971.

In addition to numerous articles to law journals, Dean Macdonald is well known as a legal editor. While at Osgoode Hall, he was assistant editor of Ontario Law Reports, and at the University of Western Ontario, he was editor of the law review which he initiated. For the last 10 years he has been editor of the University of Toronto Law Journal.

A bachelor, Dean Macdonald is the son of the late Colonel and Mrs. Ronald St. John Macdonald, formerly of Pictou County.



The appointment of Professor F. Murray Fraser, a member of the law faculty at Dalhousie University since 1965, to the new position of Associate Dean of Law, was announced in September by the president, Dr. Henry D. Hicks.

Educated in Halifax, Prof. Fraser graduated from Dalhousie with his BA in 1957 and the following year, his first in law school, he was president of the Student Union. He graduated with his Bachelor of Laws degree in 1960; in that year, in the law school's Annual Moot Court competition, he won the Harvey T. Reid prize and the Smith Shield. He also won the highest award given by the Student Union, the Malcolm Honor Award.

From 1968-70 Prof. Fraser served as a research associate to the Newfoundland Family Law Project. He is a contributor to a text on Family Law which will be published this fall. He is also co-director of a research project on child abuse, the first in-depth interdisciplinary study of this phenomenon in Canada. In 1970 Prof. Fraser was a member of the Cox Commission on Legal Aid and he has also acted as a Commissioner of Inquiry under the province's Human Rights legislation.

In the community, Prof. Fraser has participated in a wide range of activities. He is completing a term as President of the Halifax YMCA and has been a member of the boards of the Family Service Bureau, the Neptune Theatre Foundation, and the Nova Scotia College of Art and Design.

Prof. Fraser is married to the former Anne Archibald and they have three sons.





Robert T. Donald, MBE, QC, FCIS, 65, dean of the faculty of law at Dalhousie University died Tuesday, Oct. 26 in Victoria General Hospital.

Dean Donald, who, during his distinguished career gave service to the Bar, university, government, business and the community, was born in Malpeque, P.E.I., son of the late Mr. and Mrs. James Donald.

He was educated at Prince of Wales College, Charlottetown, and at Dalhousie, where he graduated with his BA in 1931 with distinction and his LLB in 1933. While at Dalhousie law school, he led his class each year and was awarded the university medal in law on graduation.

He was called to the Bar of Nova Scotia the year he graduated and was in private practice in Halifax from 1933 to 1941 and 1945 to 1949 in the law firm of Pearson, Rutledge and Donald, which later became Rutledge, Donald and Cragg. He was appointed King's Counsel in 1945.

From 1942 to 1945, he was a member of the legal department and later secretary of the department of munitions and supply in Ottawa. For this service, he was named a member of the Order of the British Empire. In 1949, he joined Brazilian Traction as assistant secretary from 1950 to 1964. He is a fellow of the Chartered Institute of Secretaries and has served on the board of its Canadian division.

He was appointed acting dean of the faculty of law at Dalhousie in August, 1969, and dean the following year.

He held a variety of executive positions in voluntary community and welfare organizations in Halifax and Dartmouth, including a term as president of the Halifax Junior Board of Trade, chairman of the Community Planning Association of Canada (of which he was made an honorary life member), chairman of the social planning council of Metropolitan Toronto, a member of the board of directors of the Halifax-Dartmouth Welfare Council, and was president of the Halifax-Citadel Liberal Association.

At the time of his appointment as acting dean of law at Dalhousie, university president Dr. Henry Hicks said he was pleased that a senior member of faculty, with a record of distinguished service at the Bar, to government, to business and the community, as well as to the university, was prepared to assume responsibility for the law school.

He is survived by his wife, the former Dorothy Groff; two daughters, Nancy (Mrs. Robert Steel), Mississauga, Ont.; Heather, at home; one son Cameron, at home; two brothers Clayton, Calgary; Everett, Kensington, P.E.I.; two sisters, Lillian, Kensington; and Thelma (Mrs. James Ramsay), Hamilton, P.E.I.

The award of Sir James Dunn Scholarships in Law to seven students who have enrolled in the first year class at The Dalhousie Law School has been announced by Lady Beaverbrook, President of the Sir James Dunn Foundation and Chancellor of Dalhousie University. The scholarships are valued at \$2,500 a year and have been awarded to Bruce Parkinson Archibald of Halifax; Terry Michael Burke of Brigus, Conception Bay, Newfoundland; Lewis Thompson Lederman of Kingston, Ontario; James Curry MacPherson of Wolfville; John David Plowman of Halifax; Robert Collingwood Strother of Calgary; and Kenneth Robert White of Montreal, Quebec.

The scholarships are awarded to young Canadians with outstanding academic records and qualities that give promise of attaining distinction in the legal profession. First awarded in 1959, the scholarships have been awarded to 60 students in law at Dalhousie in the past twelve years. Scholarships are renewable for students attaining first class standing in their studies in each year.



A Management Development Program comprising special courses, seminars and workshops for top executives, middle and senior management in the Atlantic region will again be offered during the 1971-72 season by Dalhousie University's Advanced Management Centre.

The Centre, in response to requests from the business community have developed this season's programs in three distinct series to meet the needs of managers with different levels of skills and knowledge.

The first series consists of a number of two-day seminars on such themes as collective bargaining (Oct. 26, 27); management by objective (Nov. 16, 17); problem solving and decision making (Nov. 23, 24); retail management (Jan. 20, 21); communications (Jan. 26, 27); computers and systems (Feb. 24, 25); effective promotion (March 22, 23); leadership (April 19, 20); and venture capital and the entrepreneur (April 26, 27).

These seminars are at an advanced level and are primarily for participants who have had a number of years of management experience.

The second series will offer a number of sessions designed to examine the management function. The major emphasis here will be on accounting, (Jan. 12-14); marketing (Feb. 2-4); people (March 1-3); and production (April 5-7).

The final series consists of three seminars of one day each to be given in February. These are entitled Small Business Management seminars and are designed for entrepreneurs and managers of small operations.

Arrangements have also been made for a five-part television series on specific management concepts for March; an outstanding management expert to serve as guest lecturer at the annual Business Conference in May, and a new seminar entitled Labor Relations in Action, which is also slated for May.

In addition to the management development program the Centre serves the management community through its special research projects, in-company training courses, program referrals, library and consulting services.

Two graduates of the Dalhousie Medical School, Dr. John Frank Shears Crocker and Dr. H. Lawrence Vallett, have been appointed assistant professors in the Dalhousie department of paediatrics and will carry out research at the Izaak Walton Killam Hospital laboratories, it has been announced jointly by Dalhousie University and the Izaak Walton Killam Hospital.

Selected the 1971 recipient of the Canadian Paediatric Society Medal award, Dr. Crocker studied at the University of King's College in Halifax. Following graduation from the Dalhousie medical school, he was resident doctor at the Halifax Children's Hospital from 1966-68. Prior to his return to Halifax this summer, he did post-graduate studies at the University of Minnesota with specialists-Drs. R. A. Good and Vernier.

Dr. Vallett's undergraduate studies were taken at the University of Arizona and Tulane University.

Following graduation from Dalhousie medical school, he studied at Mount Sinai Hospital in New York, Children's Hospital of Philadelphia and the University of Philadelphia, and the Halifax Children's Hospital. He has both published and presented numerous papers related to his research in paediatric endocrinology.

Glendon R. George, associate comptroller at Dalhousie University for the past 18 months, has been appointed controller.

Donald H. McNeill, vice-president (administrative), relinquishes the controllership which he has held since 1964, and will concentrate more in the future on general administrative matters in the university.

Mr. George, a native of Halifax, lives in Dartmouth. Educated at Richmond Bedford Central, Queen Elizabeth High and Halifax Academy Commercial schools, he graduated from Dalhousie with his Bachelor of Commerce degree in 1958.

John C. Barrow of San Antonio, Texas, has been appointed to the staff of Dalhousie University's Student Counselling Service.

Mr. Barrow, who has completed all requirements for his doctorate in Education and will officially receive the degree next December from Teachers College, Columbia University, New York City, obtained his earlier education at Davidson College in North Carolina and Columbia University.

His experience spans a wide range in counselling - vocational, rehabilitation, financial aid, aptitude testing in the Head Start program and working with brain-damaged children. His professional interests include short-term methods of counselling and behaviour modification; group counselling and sensitivity training; and consultation with community members such as teachers, who work with large groups of people.

Mr. Barrow is married, his wife, Elizabeth teaches a learning disabilities class for the public schools.

The four leading scorers in the Atlantic Intercollegiate Hockey League last season, including three players who established scoring records, will headline the 1971-72 edition of the Dalhousie University hockey club.

Last year the Tigers set a league record by scoring 163 goals, and with the scoring punch that coach Gerry Walford has added to the line-up that mark could well be eclipsed.

Last season the Tigers won 14 games and lost only two in league play to finish second to the Saint Mary's Huskies. The Huskies downed Dal 8-4 in the AIAA tournament final to win a berth into the nationals.

Leading the list of returnees is big centreman Pierre Gagne. The North Bay, Ont., native scored a record 62 points last season on 27 goals and 35 assists. Gagne is starting his second year with the Tigers.

Defenceman Greg McCullough was second to Gagne in the scoring race with 60 points, including a record shattering 35 goal performance. The St. Andrew's, N.B., native is starting his third year with Dal.

Team captain, Ron Naud, a winger from Rouyn, Que., also is starting his third year with the club. He was fourth in the scoring with 20 goals and 33 assists.

The biggest addition to the Tigers line-up is former St. Francis Xavier star Pierre Page. The Lachute, Que., native was the X-men's leading scorer in 1970-71 with 18 goals and a record 38 assists to place third in the AIHL scoring race. The classy centreman is a graduate student at Dal and adds impressive strength down the middle.

Maurice MacDonald, former sports editor with The Chronicle-Herald and The Mail-Star, has been appointed editor of University News, the fortnightly newspaper of Dalhousie University, and sports information officer for the university.

Mr. MacDonald, a native of Sydney, attended Sydney Academy, Xavier College and St. Francis Xavier University.

Married with three children, he was a reporter and news editor with the papers of The Halifax Herald Ltd. between 1962 and 1967, when he joined the public relations staff of Canadian Pacific Railway in Montreal.

In 1969 Mr. MacDonald rejoined The Chronicle-Herald, for a short time at Sydney before being appointed sports editor.

He is president of the Metro-Valley Junior Hockey League, a member of the selection committee of the Air Canada Amateur Sports Award, and a member of the steering committee of Sport Nova Scotia.

An application for a club license was made by the Dalhousie Faculty Association to the Nova Scotia Liquor License Board at a public hearing in Dartmouth on Sept. 10.

The Board of Governors of Dalhousie University has already approved a request from the association to use part of the old law building on the Studley campus as the Dalhousie Faculty Club.

If the application to the licensing board is approved, the main floor of the old law building will be converted into club premises, with dining room, lounge and bar facilities, and the club will open in the fall.

Dalhousie has a total of about 850 on its faculty; approximately two-thirds are full-time, and about half of the total are members of the Faculty Association.

An annual prize in preventive medicine was offered this year for the first time at Dalhousie University. Awarded for the highest overall performance by a third-year medical student, it was won by Ewart A. Morse, son of Dr. and Mrs. W. I. Morse, Yarmouth.

Known as the Dr. W. Sidney Gilchrist Prize, the award perpetuates at his alma mater the name of the late distinguished medical missionary to Angola.

It will be awarded annually to a third-year medical student of high academic standing in preventive medicine during his first three years and for a high standard of practical performance during his third year in the Comprehensive Health-Care project.

The Project charges a student with responsibility for the health counselling of a patient and his or her family and it is supervised by a family physician preceptor or member of the staff of the Family Medicine Centre. It provides the student with his first practical experience in working and studying with a healthcare team of nurses, social workers and other professions.

The memorial to Dr. Gilchrist was endowed from grants provided by the Dalhousie Medical Alumni Fund. Dr. Gilchrist had specialized in public health medicine and devoted his career to social and preventive medicine in Africa.

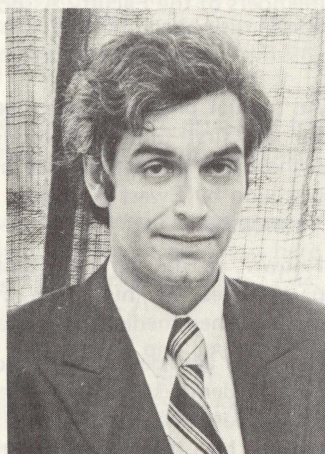

Dalhousie University's Transition Year Program which enrolled young Blacks and Indians last fall in a year long course designed to assist them to overcome disabilities which prevent their being admitted to university, will continue for at least another year.

In making the announcement, Dr. P. D. Pillay, TYP director, said that 14 of 23 young people enrolled had successfully completed the program and have been recommended for admission to university. He noted that the success of the first year's class was the chief factor in the decision by the university to continue the program for the coming year.

Dalhousie University has an ombudsman. He is Ian Gordon Chambers of Dartmouth, a third-year law student. In making the appointment early in September, Dr. Hicks stated that "The establishment of this office, which has been a cooperative effort between the Student Council, the university's Student Services Committee, the Senate and the Board of Governors, comes at a time when the university is growing rapidly and its operations are becoming more complex. The need for means to facilitate communication and to deal with problems and complaints quickly and efficiently is therefore increased."

Mr. Chambers, 24 and married, graduated from Prince Andrew High School in Dartmouth. During his first three years at Dalhousie, from 1963 to 1966, he held the General Motors Scholarship and graduated with his BA, winning the University Medal in English. He was the 1966 Rhodes Scholar and studied comparative literature at Baliol College, Oxford, and there obtained his B.Phil. degree in 1968. He was awarded a Sir James Dunn scholarship in law (1969-72) and is now beginning his final year of law. He is President of the Law Students' Society for 1971-1972.

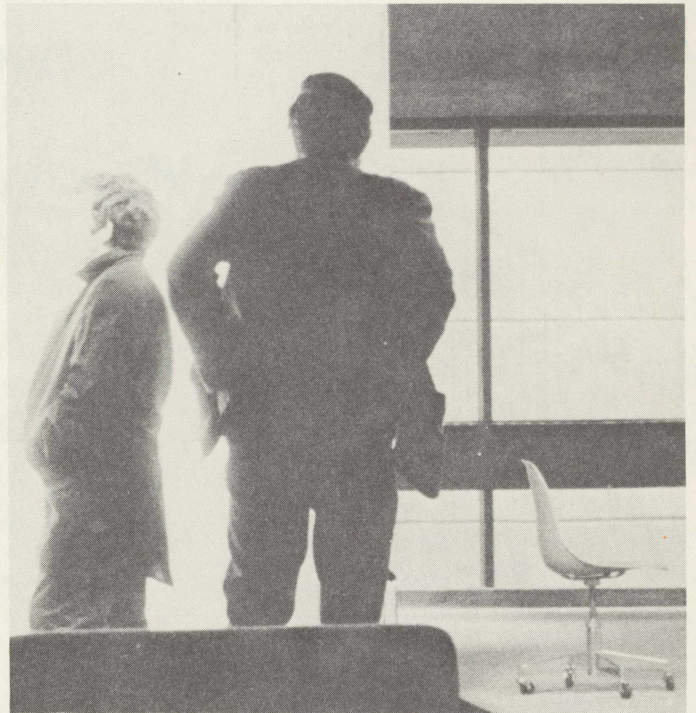
