Dear Tom:

We are very pleased that you have agreed to write a history of Bowater Mersey for our 50th Anniversary in 1979. From your comments at our meeting, I am certain that this will be a worthwhile project indeed.

As we now see it, the book will be approximately 6 inches by 9 inches in size, hard cover, with about 100 pages of copy plus up to about 20 photos. I have asked Jack Kyte to work with you and would ask you to keep in touch with him when you need assistance. He will also help in selecting printers and paper and in doing other work as you see fit.

Your suggested deadline for a manuscript of May 1, 1979, with a view to publication by our November 27th Anniversary date, is fine with us.

As we agreed at our meeting, Bowater Mersey will reimburse you in the amount of $\$7,^{\oplus \odot}$ for your services in preparing this book. Also, as we discussed, I will make arrangements for one-half of this amount to be paid to you before the end of 1978 with the remainder to be paid at a mutually convenient time in 1979.

Again, let me say how very pleased we are that you have agreed to help us with this project. We all look forward to working with you in the coming months in making the Mersey history a lasting memento of our 50th Anniversary year.

Dear Bobs

Thank you for your letter enclosing cheque for \$3,500, the first of two instalments in payment for the work of compiling the Mersey Paper history.

Jack Kyte has kept me well supplied with Company scrapbooks and secords of directors' meetings, from which I have been making typewritten notes for the bone structure, with accurate names, dates, and so on. I have nearly completed this vital part of the work. Upon it I can build the flesh and sinew, from personal narratives, having regard to the progressive changes in mill operations, shipping, sales, forestry and wood-cutting operations, public relations, and the human side of it all.

In specifications for the book, you mentioned that, apart from space for photographs, you required about 100 pages of text, each page being 9" by 6".

Working this out by printers' measure (six letters or punctuation marks counting as one word) this gives a total of about 35,000 words, and I shall aim for that.

The figure is flexible, of course, and I can enlarge or reduce it if the need arises. There is ample material, indeed the hardest part, as in all historical work, will be in choosing what the printers will have room for.
