I hereby revoke my will dated 16 October 1973.

Since the death of my wife Edith Margaret Raddall in 1975 I wish to make a new will to this effect:-

FIRST: I GIVE, DEVISE AND BEQUEATH to the Building Fund of Zion United Church, Liverpool N.S., the sum of FIVE THOUSAND DOLLARS, to be used in any way the trustees of the Building Fund may choose.

SECOND: I GIVE, DEVISE AND BEQUEATH to my daughter Frances (Mrs. William Dennis) of 230 Havelock Road, Riverview, New Brunswick, the sum of TWENTY THOUSAND DOLLARS. In the event of her death prior to my own, this sum is to be held in trust for her children Gregory, Terence, Stephanie and Tracy, and is to be paid to them in equal portions (\$5,000 each) when they attain the age of twenty years.

THIRD: I GIVE, DEVISE AND BEQUEATH to the Governors of Dalhousie College and University, for the purpose of its Library, the copyrights on all of my published and unpublished works, together with all future monies which may be paid for the use of these works, including printing or re-printing, in whole or in part; also all monies received for these works, in option or permission fees or royalties, in connection with stage, moving picture, television,

radio, or any other public performances. The use and disposal of these monies shall be for the benefit of the Dalhousie University Library in the manner determined by The Governors of Dalhousie College and University. inx thex manner

The Governors of Dalhousie College and University may also sell any of such copyrights, with the proceeds of such sale to be used for the benefit of the Dalhousie University Library.

FOURTH: Under an agreement with the Dalhousie University Library dated November 2, 1973, for the purchase of my papers and certain other objects, most of which have been transferred already to the Library, I now direct that the following items be placed at the disposal of the Dalhousie University Library:-

- 1. All of my remaining correspondence files.
- 2. All of my remaining diaries.
- A silverware tray with an engraved inscription from fellow staff members of the Mersey Paper Company, 1938.
- 4. A barometer bearing an engraved plate from fellow townsmen, 1942.
- A silverware salver bearing an engraved inscription from the West Nova Scotia Regiment, 1949.

FIFTH: I GIVE, DEVISE AND BEQUEATH the entire residue of my estate to my son Thomas Head Raddall Jr., of Hunt's Point, Queens County, N.S., or in the event of his death prior to my own, to his children Thomas, Deborah and Blair, to be paid in equal parts on their attaining the age of twenty years.

SIXTH: I appoint my son Thomas Head Raddall Jr. and the Montreal Trust Company, or their legal successors, to be the executors and trustees of my estate.

- (10) I bequeath to the Endowment Fund of the Queens County Museum, Liverpool, Province of Nova Scotia, the sum of Ten Thousand Dollars (\$10,000.00).
- (11) I bequeath to the Victorian Order of Nurses, Liverpool, Province of Nova Scotia, the sum of Five Thousand Dollars (\$5,000.00).
