

Dear Mr. MacNamara:

Even before my time as Chairman complaints were made by members of the Regional War Labour Board and by parties appearing before it as to the utter inadequacy of the Board's quarters for the purpose of its work and in particular of public hearings.

At its last meeting the Board passed the following Resolution on the subject:

"In view of the fact that the Chief Executive Officer had on several occasions been instructed to attempt to secure better quarters for the Board, and reports to the Board that after various conversations with the local Resident Architect he has been unsuccessful in doing so, that this Board through its Chairman draw the attention of the Minister of Labour of Canada to the above and request the good offices of the Minister in obtaining quarters more habitable and less dangerous to the health of the Board and its staff than the present".

The Board Room is on the ground floor adjoining a hill in a busy part of the City. It is impossible to get ventilation because of the necessity of opening windows butting on this Street from which come noise and dust. The Board Room itself is less than the size of the room which I formerly occupied in the main corridor of the Confederation Building. We have had and will have increasingly public hearings at which numerous parties, council, company and union officials appear and it is obvious to all that the efficiency and conduct of such hearings is impaired by the small size and location of this room.

Accordingly, on behalf of the Board, I request that better quarters be obtained for the Board as soon as possible. Perhaps it would be possible for us to swap our quarters for those occupied by National Selective Service in the same building. At all events something should be done to improve the present facilities.
