## WELDON CHAIR

After the death of the late Dean Weldon in 1925 a number of graduates of the law school advocated the establishment of a Weldon Chair as a permanent memorial. The University had pledged itself to King's College not to make any appeals for money until the successful conclusion of the the King's Campaign, consequently the movement to establish a Weldon Chair of Law had to be postponed until the completion of the Kings campaign at the beginning of this year. The project was formally launched by the Hon. R. B. Bennett, LL.B., LL.D., K.C., P.C., a graduate in law of the class of 1893, when he addressed a meeting of the Nova Scotia Barristers' Society on March 10th of this year. At that meeting Mr. Bennett urged the Nova Scotia Barristers' Society to take the lead in a movement to raise \$100,000 to establish a Chair at the Law School as a memorial to the late Dr. Weldon. He undertook the responsibility for the necessary collections in the western provinces and pledged the sum of \$25,000 as his personal contribution to that object. The meeting responded enthusiastically and instructed the council to undertake the necessary measures.

The Council of the Nova Scotia Barristers' Society, at a meeting held Tuesday, March 20th, appointed a sub-committee with power to create the necessary organization for the raising of the funds. The Committee, consisting of R. H. Murray, LL.B., K.C., President of the Nova Scotia Barristers' Society, Hector McInnes, LL.B. K.C., T. R. Robertson, LL.B., K.C., T. W. Murphy, LL.B., K.C., Col. W. E. Thompson, LL.B., J. E. Read, K. C., met on Monday, March 26th, and has already made very substantial progress. An organization has been tentatively established and it is expected that the active work of appealing to the graduates and students of the Dalhousie Law School will be well under way within the next few weeks.

## GENEROUS GIFT

Signalizing the seventieth anniversary of the marriage of his parents, Peter and Elizabeth McKenna of Dartmouth, James D. McKenna, of St. John, president of the New Brunswick Publishing Company, proprietor of the Telegraph-Journal and the Evening Times-Globe in that City, has established "The Elizabeth McKenna Scholarship Fund."

At the end of five years the fund will amount to \$5,000 and provision is made by which it will increase to \$25,000.

The income is to be used for the establishment and maintenance of aid scholarships, to be called "The Elizabeth McKenna Scholarships". They are to be open to students of the Maritime Provinces entering the Faculty of Arts and Science, on grade XI or XII certificates, and are tenable for one year. The first scholarship, of the value of seventy dollars, will be awarded during the coming summer. Candidates desiring to be considered must make application to the University. Applicants must be in every way worthy and in need of financial assistance, and their scholastic attainments shall not be taken into consideration.

Dalhousie University is lacking in provision of scholarships of this kind, and President MacKenzie asserts that the University is very glad to be the recipient of this generous gift of Mr. McKenna. No memorial could be more appropriate. It will be the means of helping boys and girls to get an education generation after generation

## MUNRO DAY

The first Dalhousie Founders' Day Celebration which was held on the evening of March 9, was an unqualified success. G. Fred Pearson, Chairman of the Board of Governors, presided. During his introductory remarks he spoke in terms of admiration and affection of the life and work of the late Mr. George S. Campbell. President MacKenzie then read an address, tracing the growth of the University and feelingly referring to the outstanding benefactors of Dalhousie. He was followed by J. Gerald Godsoe, B. A., President of the Council of the students, who presented the guest of honour, the Honourable R. B. Bennett, LL.D., K.C., P.C. (LL.B. '93), with an illuminated address of welcome from the students. The Honourable Mr. Justice Russell, LL.D., Professor Emeritus of Dalhousie Law School, now introduced his former pupil, the Honourable Mr. Bennett as the speaker of the evening. In the course of an inspiring and instructive address, Mr. Bennett paid heartfelt tributes to the memory of the late Dean Weldon and the late Dr. G. S. Campbell. His remarks were replete with interesting reminiscences of the old college by the Sea. "There were great joys in those days", he said, "joys, sorrows and successes". He appealed to the students to find their life work in Canada if possible and to remember that true success is not found necessarily in material riches, but in doing your best whatever task you take in hand. In conclusion he wished the students success and that they would be able to look back on work well done. Three hearty cheers were given for Mr. Bennett at the conclusion of his address. The Dalhousie Symphony Orchestra, under the baton of S. Singer, contributed largely to the musical part of the program. The Dalhousie Choral Society led the singing of college songs. The evening's program was broadcast over radio station C. H. N. S.

Of the Law Class of 1893, Mr. Bennett's class, the Honourable L. P. D. Tilley, H. F. Puddington Judge J. A. Grierson and G. A. R. Rowlings were unable to be present at the meeting. The remainder of the class still in the Maritimes, His Worship Mayor Kenny, the Honourable D. A. Cameron, the Honourable J. A. Fulton, Major H. B. Stairs, D.S.O., and Colonel W. E. Thompson were present to welcome their old classmate, and occupied seats of honour on the platform.

Rev. John H. Cameron retired last summer from the active pastorate when he resigned his charge at Trafalgar Road Church, Vancouver, after a pastorate of seven years. He has given forty-five years of ministerial service to the church in Canada. He began his ministerial work as missionary in Manitoba and Canadian Northwest. Practically all his ministry has been in Western Canada. He organized seven congregations, built five churches and three manses Rev. John P. MacPhie who wrote an interesting biographical sketch of him which appeared in several Canadian papers says of him, "His whole career has been distinguished by energy, faithfulness and self-sacrifice." Mr. and Mrs. Cameron will continue to make their home in Vancouver.

### RARE AUTOGRAPH LETTERS

Two beautiful oak and glass cases, designed by Professor H. R. Theakston, containing rare and valuable autograph letters, autograph programs of famous musical composers, operatic and recital singers, pianists and other instrumentalists, and programs of famous concerts by these artists are the latest addition to the Colonel W. E. Thompson Library of Musical Literature and Adenda. The valuable contents of the cases are the gift of Colonel Thompson's classmate at Dalhousie, Dr. J. D. Logan, who founded the Library in his classmate's honor, 1924.

Each autograph letter, photo and program is mounted with a card, indicating the name and distinction of the musician. Amongst the contents are autograph letters of Wagner, Paderewski, Mme. Melba and of Canadian composers such as Clarence Lucas, Gena Branscombe, Williann Octavius Forsyth; autograph photos of such grand and light opera singers as Mme. Edvina, creator of the title role of Charpentier's "Louise," and Christe MacDonald—the one a native of Quebec and the other a native of Pictou, Nova Scotia. Some of the programs bear the autograph signature of Fritz Kreisler, John MacCormack, Leopold Stowkowski (unique in scrawl) and the famous Galli-Curci. The ordinary letters are Richard Wagner's, dated 1857, and Paderewski's; and the autograph of John Phillip Sousa is unique in expressing the man himself. The collection is, for the most part, the result of gifts from Musicians to Dr. Logan, extending over twenty years. The cases will be on permanent exhibition at the MacDonald Library.

#### A BRILLIANT BLUENOSE

The Policy Holder, an insurance journal published in Manchester, England, pays this tribute to a brilliant young Nova Scotian in the Government service at Ottawa:

"One of the most observant men present at the recent international Congress of Actuaries was Mr. George Daniel Finlayson, the Canadian Government officer who superintends the department of insurance at Ottawa. He is a young Canadian, educated at the old charter-university in Halifax, Nova Scotia, and was appointed Superintendent of Insurance for the Dominion on Fitzgerald's retirement in 1914. A few weeks ago, Finlayson addressed a meeting of Canadian life assurance managers at Toronto, giving his impressions of the international congress. His remarks have aroused intense interest in the Dominion and elsewhere."

Mr. Finlayson is a native of Merigomish, Pictou County, and a graduate of Dalhousie. He is recognized as one of the foremost actuarial authorities and insurance experts in the Dominion.
