Dear Edwin:

Welcome back fromIndia. I amanxious to hear about your impressions and adventures.

Here, how, is really good news. I am really excited about it because it seems to me now we really are on our feet and can do something important.

The CIDA grant has been signed, sealed and delivered. I am enclosing the letter of agreement. It has taken some doings, and a lot of patience, but we did it, and CIDA is as happy with it as I am.

This means (1) we can, and must, do a first-rate job on this second course ("Class B"). It will be a cooperative effort between the IOI and Dalhousie — an association which I think can be extremely productive. The Dalhousie Oceans Studies Council (DOSC) has already appointed a sub-committee to work out a curriculum proposal. We then shall have an international work-shop in New York on the week-end of March 15/16 — similar to the one we had in Malta in 1978 for the sea-mining course — to produce the final curriculum and work plan. We should have our first "Class B" course in Malta in the autumn of 1980 (October/December); the second one will take place at Dalhousie in the summer of 1981.

Now I think it is very important that you should come to this workshop, which will be preceded by a Planning Council meeting on the evening of March 14. (Do not worry about money: IT IS THERE, FOR THIS PURPOSE: IT IS BUDGETED IN THE CIDA BUDGET). I think your presence is so important because of the wider perspectives that this development is opening:

(2) I have the feeling that the IOI now is playing an important role in the old University: and that there is room for bigger developments. Suppose that, besides these two annual courses, on all aspects of ocean management, for students from developing countries, funded by an international scholarship programme, we add a third element: A Mediterranean programme, both research and training: for which there is a real need: an idea whose time has come: and, in the present situation. Malta is the only place which can realize it — well, then we really have a con-

crete beginning of that Ocean University we have been dreaming about. On this concrete beginning, there are many possibilities for further action.

It seems to me, we have really turned a corner. We can now do something that is durable and will outlast the present international crisis, which will reflect itself also on the Law of the Sea Conference, I fear.

Sidney will be coming to the New York meeting, and, of course, Arvid. We have assured the collaboration of the competent UN offices. We really can do a job.

I'll be in Europe on February 16/17 and shall give you a call.

I am enclosing three copies of the IOI accounts for the year ending 30th September 1978 for your signature. Please return them as soon as you can.

As I told you on the phone I shall be going to London later this week and I shall try to see Mr Maddox at the Nuffield Foundation. Quite frankly I do not think there is much chance that the Foundation will come up with any money, and I wonder where funds are to come from. I have just paid a bill for £M2,360 as the advance on accommodation etc and this has used up not only the \$3,000 which you telexed from Zurich but almost all the balance of the SIDA grant.

As I also told you the IOI is remaining within the Old University, and Fox has received her work permit. We need funds badly and quickly otherwise we are going to find ourselves at a standstill. I understand from Fox that Paul White is not coming now - which to some extent is a relief as the expenditure for travel will be saved. I assume that he is making all the necessary arrangements regarding staff etc and I am leaving everything at this end in the hands of Fox. We shall now need money to pay her a salary and I want to know how much this should be. We should assume that she came on the 'payroll' of the IOI on 1st January 1980.

Dear Elisabeth,

I have received your cable and your letter of the 19th November 1979. I have sent \$7,000 to your account at Halifax, \$5,000 for the Project Director and \$2,000 'for various travel expenses'.

I have not yet sent the other \$5,000 as there are certain formalities that have to be observed regarding the importation of equipment. The University can import equipment duty free, but the order has to be made by us and the equipment addressed to our Finance Officer. Also, we have no video tape equipment and its importation is strictly controlled as colour television is not allowed here except in very special cases. It would therefore be better if you would let me know precisely what items are required so that we can try to get an order placed after the necessary formalities have been gone through.

Quite independently of this particular case, you should keep in mind the fact that in order to have equipment duty free it has to be addressed to the Finance Officer - this just in case some form of equipment is sent over in connection with these courses. Incidentally the duty on electronic equipment is very high - in the case of video tape recorders it is about 130%, so errors could be very costly.

Please excuse the informality of this stationery: In view of the slowness of the mail from Canada, I should like to mail this letter before leaving Europe again.

I should like to confirm the content of my cable from Cologne: Kindly transfer the amount of U.S.\$ 12,000 (twelve thousand) to my account No. 13137 at the Royal Bank, Armdale Branch, Halifax, N.S. Canada. This is part of the grant from SIDA. Sweden, for the final preparation of the first course of our training programme, including the acquisition of audio-visual material.

While I will give you an exact accounting prior to the opening of the course next April, I can tell you already at this time that \$5,000 are needed for the Project Director, Professor Paul White of McGill University in Montreal, \$2,000 are needed for various travel expenses, and \$5,000 are needed for the acquisition of video tapes, films, and materials.

I hope this transaction will already have taken place when you receive this letter. Otherwise I should ask you most urgently to complete it as fast as possible. The funds are needed now.

Dear Elisabeth,

I am writing in answer to your letter of the 15th August, 1979.

- 2. As I told you on the phone I cannot carry out the work of Project Director myself. I have accordingly asked Louis Saliba whether he would be prepared to undertake this task, but after careful consideration of what would be involved he came to the conclusion that he could not handle it along with his many other tasks. We are therefore back to square one.
- 3. I have not answered your cable asking whether April 14th to July 4th would be possible for the training course. As far as dates are concerned, I am sure there would be no difficulties. The question is whether there will be a Project Director, whether funds for the preparatory stages would be available in time, what sort of answer you will get from Mizzi and Abela, and of course what will be happening to this place here. Once you have written to Mizzi and Abela it is now important that you know the answer before you commit yourself completely this quite apart from the need to identify a Project Director in good time.
- 4. I have not yet received any funds from Sweden or the Netherlands. As soon as I receive them I shall carry out the instructions you gave in your letter of 4th August.
 - 5. I have sent \$3,500 to Geoffrey Kesteven on account of what we owe him. I have sent you a copy of the instructions I gave to Ronnie Attard. If you still have it please send it back with a note that you approve of the payment. I shall try to settle with Geoffrey as soon as sufficient funds are available.
 - 6. There is one other matter which affects Geoffrey, though indirectly. At the beginning of 1978 you had sent Fox a pre-paid ticket to Hawaii, but this arrived too late and the ticket had to be bought from IOI funds. In approving the issue of a ticket from IOI funds Geoffrey had made himself responsible for obtaining a refund from you as soon as it was received. I have no record that such a refund was ever made. The amount involved was £M483.25,0, i.e. \$1,400. The auditors have been querying this amount and I should like to clear it up. Please let me know the position.

7. I hope that any outstanding matters can be cleared when you come over in October.

Dear Elisabeth,

I am writing in answer to your request addressed to the Board of Trustees regarding Roger Vella Bonavita, and also (in a more personal vein) to make a comment on what you have written to Maurice Abela and Edgar Mizzi.

Regarding Roger, you already know my views: I think you are being less than fair to him - he has done a very good job; his application for a job has not stopped the Commonwealth Secretariat from providing a number of scholarships as you had expected; and quite frankly I do not like the way the note to the Trustees is worded. Anyway that is my view and I do not agree with you.

Regarding your letters to Abela and Mizzi I could not help thinking that the same sort of comments could be made about them as you have made about Roger's application. You wrote assuming that Roger's connections with IOI have already been severed when the members of the Board of Trustees have not yet had time to answer your note; and you have added your own contribution towards making sure that this University has no chance to recover. I have been fighting a very difficult, and painful, rearguard action against impossible odds in the hope (and it is really the only hope) that someone will see sense yet, and I feel very hurt about the way you are prepared to write the University off - that is just the sort of act that cancels much of the patient work that has been going on quietly and persistently.

I shall write about Geoff Kesteven soon.

Dear Edwin:

The enclosed letter, alas, is self-explanatory. I know you do not see the situation the way we do: I have been scrupulous in consulting with everybody -- that is why the decision took so long -- and there is really no other way.

The question now arises: what next. I called Father Peter, and, when I talked to him he was optimistic in the sense that he could take over the job at least on a temporary basis, but then, after consulting with UNESCO, he found that his previous engagements with UNESCO did not permit him to take on this new and rather burdensome task.

I still am convinced we must have a Maltese if the course is to take place in Malta. Of course it would have been ideal if you yourself could have taken on this job — at least on a temporary basis. I would be working closely with you, especially on the international scene, and Fox would do all the leg work. Don't you think you could do it under these circumstances?

I have consulted with Arvid, and with my friends here in the Maltese Delegation, and if you really cannot take it, our next suggestion would be Louis Saliba. I understand that he might accept it, provided we give him enough assistance. And of course he is well connected. He would have to work closely with me as he does not know anything about the field.

In the meantime I am putting together things as best I can (manual, teaching material, correspondence with applicants, additional fund raising). In October I intend to come to Malta and to hand over the programme in very good shape to the new person whoever he may be.

Please let me have your advice as quickly as possible. The first course should begin on March 3.

We cannot set the definite date for Cyprus until we know the date for the next L.o.S. session — which should be next week. The Government of Cyprus proposes the second half of March. They will pay all expenses (including hotels) for 70 participants. That is really magnificent.

As you are aware the IFDA grant has been received and action taken as originally requested by you. I should still like to have the appropriate supporting documents when they surface as the auditors may not be satisfied with just an extract of a letter from you.

Dearest Edwin:

I have your two letters. It would be so much better to get together and have a good talk. By correspondence complicated matters tend to become more complicated yet.

We have three major points to sort out.

Let me start with the easiest, that is, the IFDA grant.

I am very sorry that I cannot produce, at this moment, the letter of agreement from IFDA. It is in one of my 100 boxes that just arrived from Santa Barbara and which will take a while to put in order. The letter, however, was very brief and simple.

Our application was based on our project outline, "Marine Resources, Ocean Management and International Development Strategy forthe 80s and Beyond, ofwhich I am enclosing a copy. This project shows a budget of \$150,000. What IFDA paid for was the project shows a budget of \$150,000. What IFDA paid for was the "conceptual, policy-oriented paper (30-50 pages), described on "conceptual, policy-oriented paper (30-50 pages), described on be under para 9 and 10. This includes fees for the two project directors for the first year, which already would be \$35,000, and it includes secretarial assistance for the first year (\$6,000). Arvid and I (the two project directors) agreed that \$15,000 would go to the University of Southern California (Institute for Marine and Coastal Studies) and \$10,000 would go to the Center. Out of these, \$6,000 go for secretarial assistance, and \$4,000 go to me. Actually, I let the Center spend them on Jean's salary, but that is my own business.

\$5,000 were transmitted to the Center last June, upon signing of the contract. You transmitted them yourself. These are the other five, and you will agree that your auditors can find no fault with this accounting. I sincerely hope that you have received the funds in the meantime, and that you telexed the amount to the Center and to Jean (Jean does not work at the Center any more; Center and to Jean (Jean does not work at the Center any more; therefore I asked you to send it to her directly); upon receiving my cable. It would be terribly embarrassing for me if you did not.

Sorry there was no overhead in this grant. It was such a small grant. I did not see a penny of it myself, although I did most of the work, including drafting the project and negotiating the grant. If the EEC grant comes through now, which is to provide the bulk of the budget for this project, you will get your overhead.

Now, the very bitter question of Roger. Let me begin by saying that I completely agree with you about all the work and enthusiasm that Roger put into this training project. The more stunned I was by what he has done. It is not that I am reading things into his letter which are not there. What he has done in plain words is to inform one of our major prospective funders that the project they were to fund is not viable, because the Canadian grant fell through; that therefore he, the Director, wants to leave Malta and look for another job.

"What then has gone wrong," he writes, "It is not possible to run a programme of this nature in a country with limited resources in teacher, and facilities, unless a fairly substantial sum is first invested in expanding the library, purchasing teaching aids and producing special course materials..." Anticipating a negative reply from CIDA, he concludes, "This disappointment is the latest in a series which, taken together, have led to my decision to try to leave Malta and to pursue my interest in development projects elsewhere." He does not mention what the "other disappointments" were. Then he follows up with his second letter: "It is now certain that the training programme I have been trying to set up for the International Ocean Institute of this University will not be supported by the Canadian international Development Agency (C.I.D.A.) at the vital initial phase. Consequently I am confirming my application to the Secretariat."

A man who writes these letters to a prospective funder cannot continue as Director of the project he has pronounced dead. I take his letter to be tantamount to a resignation, which we must accept. I am very sorry about this because I like and admire Roger.

of course I will not take this action on my own, but I will submit it to the Planning Council. I also will propose that he be indemnified for the work he has put into the project, once the funds are there.

Fortunately, the Commonwealth Secretariat has confirmed five fellowships for \$7,200 each. Also the Government of Germany has confirmed five fellowships; the Government of the Netherlands, one. I am expecting a dozen more. The first course thus will be completel self-supporting. All we need is about \$50,000 for the preparatory phase, the teaching materials, etc. I have not the slightest doubt that I will find these, and that the first course will begin next February.

Now, as to Fox: Again, I agree completely with you that Fox has done a splendid job for the IOI, and I most certainly want her to continue to do so. But it seems to me, it is not only of use, it is essential that her position must be put on a better footing, in other words, that it must be regularized. This has been the unanimous advice of the Planning Council for the last two years. Had it been done, I could have paid her salary to the IOI instead of paying it to a Swiss bank account.

I am, at the mo ent, really and totally at the end of my rope and simply cannot continue to pay her out of my pocket. But we do have two grants coming, and her salary could legitimately be split and charged half to the one and half to the other grant. One is from the Netherlands, for the Ocean Yearbook. It has been approved, and if it is not yet in your hands, it should be any moment. It is \$10,000. The other is for the Training Project, and I will know these days how much it is (Red See Commission).

As forthe last question, air fares, etc., we'll discuss that when we meet next. Certainly arrangements will not be made with UNITREX for Cyprus, for the simple reason that our California operations have ceased. But I should like to point out that UNITREX has done an outstandingly good job for us. We have, previously, made all sorts of different arrangements, package deals, air line arrangements; and nothing has worked better than UNITREX. Quite a number of our participants have paid their fares themselves, in the past, and we certainly will continue this method. Actually we are paying only for members of the Board of Trustees, of the Council of the Yearbook Editorial Board, and of staff. We are paying for people from Third-World countries: but for these we get grants (For Pacem in Maribus IX we raised \$15,000 for this purpose). All others pay their own fares. Nevertheless, when we are in a far-out place like Okinawa or Yaounde, the bill runs quite high. Cyprus will be a lot cheaper. Also, the Government of Cyprus will take care of all local expenses, including hotels (a major item on the Yaounde bill).

I guess that covers it for today. All the very best, and we'll be in touch soon.

My dead Elisabet

I have to admit that yesterday's phone call left me considerably disturbed. I know how much work Roger has put into the Project, and how willingly and enthusiastically he has gone about it; my reactions, as you will have gathered, were that you were being rather unfair in your conclusions about him.

I have read Roger's letters again. I think he has been very fair in the way he put the matter when applying to the Commonwealth Secretariat. I cannot imagine the Commonwealth Secretariat to be so naive as to believe that such a Project would get off the ground without initial funding of a considerable amount; or that they would write off completely any help they were really prepared to give because of what Roger wrote. The position is simply that the Project cannot start in October because of the lack of funds from CIDA; but there is nothing to stop the Project from starting if other funds are found. Again I cannot believe that the Commonwealth Secretariat, if they really considered the Project worthwhile, would not be prepared to provide help once the starting funds are available. Roger made it quite clear why he was applying at the time he did, and his second letter was simply a follow-up letter which he had already indicated he would be sending - it added nothing new. Anyone looking at letters with suspicion can read whatever they wish into them: if you have now been told that the Commonwealth Secretariat will not be providing any scholarships, it must be because they had already decided that themselves for other reasons! Your own letter to Mr Fabre is itself open to that sort of interpretation and I am sure that it was far from your intention to give that impression.

I think this matter has highlighted the precarious way in which IOI has been existing since it was founded. As I have told you in my other letter of today regarding the Cyprus meeting, I know of no PIM Conference which did not end in the red, having to be bailed out by yourself, and with the IOI itself indirectly losing through not getting any overheads from grants.

That things have been as successful as they have been so far has been mainly due to your own efforts and your willingness to underwrite losses. But I do not think you are appreciating sufficiently the efforts put in by so many others. I am thinking now mainly of Fox and, more recently, Roger. It is no use saying that Fox's position must be put in a better footing; the necessary funds have to be forthcoming - (and I have to come back to this every time) there have never been any funds left from which to make overhead charges.

I liked what Mario Ruivo told me about the plans for the Yearbook (I do not know to what extent they have been adopted by the Planning Council), that it should be the main on-going function of the IOI with a base here, and with a proper Secretariat. This makes sense, and through having one provocative topic in each issue there would be scope for further research and meetings before that particular topic is dealt with further in a later issue. This would be better than a continuation of the series of PIM conferences which have now attained their main purpose in so far as this was attainable. Meetings of smaller groups on specific topics would be effective – and much less expensive!

One last point: I have received your telegram regarding the IFDA grant, but have not yet received the funds. As soon as I get the money I shall telex the \$7,500 to the Institute for Marine and Coastal Studies, University of Southern California. Before I send the rest I should like to have the supporting documents which would justify the transfers to the auditors' satisfaction. The best thing would be for you to send me a copy of your application to IFDA, and of their reply - together with a statement as to the purpose of the transfer to Jean Muller and to the Center.

Coming back to the starting point of this letter: my own view is still very strongly that Roger should continue with his work, certainly until we know the outcome of the Saudi-Sudanese Red Sea Commission's decision. News should reach us of this within the next fortnight, and we shall then know whether the Project has any chance of starting in February. In the mean time I am letting things proceed on their present footing



I have seen van Ettinger's provisional budget for PIM X in Cyprus. As far as budgets of this type go, it seems all right. The comments I wish to make are really obvious ones, but from past experience I feel they should be made anyhow:

- (a) It is extremely important that the conference <u>accounts</u> do not actually end in deficit. The provisional budget assumes that everything will go smoothly: in most cases, whilst one can control expenditure to a certain extent, the funding can go very badly wrong and has done so before!
- (b) To avoid ending in deficit it is essential to create some mechanism which will determine whether the meeting is actually to go ahead or not. In the case of the Okinawa meeting the Board of Trustees had said that no firm commitments should be entered into unless half the amount required had actually been raised this procedure was not in fact followed and eventually a sizeable balance had to be provided by an 'unidentified' donor, who turned out to be yourself. A repeat of this <u>must</u> be avoided. The 'Okinawa condition' regarding half the funds should be insisted upon, and must be adhered to.
- (c) It must also be made clear to participants whether their passages are being provided free or not (in some of the last circulars the statement in this connection was somewhat ambiguous). I would prefer seeing the participants bearing some of their passage expenses themselves, with the possibility (which should be explicitly stated) that in special cases the full cost would be met. This would not only reduce expenditure but also reduce the number of 'passengers' at the meeting.
- (d) I do not know what went wrong with the Yaounde arrangements: whether there had been a misunderstanding regarding the commitments of the Government or a change in their attitude towards meeting the internal expenses; a recurrence must be avoided.

(e) There surely must be a cheaper way of getting people over than sending them a pre-paid open ticket! The usual formula is to offer a refund (of the full or part of the amount) of the cost of an air ticket at the cheapest tourist rate, and then to leave it to the individual concerned to book the ticket and to claim the refund. This will (a) avoid unnecessary charges on tickets which are not used - quite apart from the frustrating delays in the arrival of pre-paid tickets, and (b) delay the actual payment for a few weeks thus giving a little extra time for funds to be found.

I know that some of these comments are relatively trivial, but even small amounts may result in an embarrassing deficit. I do not remember any of the PIM conferences which did not end in the red - and it has always been at the expense of the 'unidentified' donor, and of the IOI itself which did not get any payment towards overheads.

The allocation in the Estimates for the 'operations' from Malta for the meeting seem all right — though I would have preferred a flat 15% overheads charge.



Sorry I did not get to Malta this time: I would have loved to see you, and talk about a lot of things.

I am glad, however, that things, at least as IOI is concerned, seem to be definitely moving. We had a good meeting with Roger Vella Bonavita in Zurich. The grants are coming in, and with our three ongoing projects I think we ought to be reasonably pleased.

Today two urgent matters:

You remember, on April 14 I transmitted, through the Swiss Bank, U.S.\$2,000 to the IOI. On April 15 I wrote to you, requesting that a number of payments should be made, as soon as you received these funds. Among others, I requested that \$383 be paid to Aaron Kozak, to reimburse him for his ticket to Mexico. However, Aaron tells me that he has not received his check. I would be grateful if you would check up on this and send him a draft or certified check (immediately cashable) as quickly as possible.

Did you make the other payments requested in that letter? Did you ever receive that letter, written from Geneva? I have no copy as I wrote it from my home in Divonne, but I kept my hand-written note. The payments I requested were: Laque, \$353, for his trip to Mexico. K.O. Emery, \$37.96 (reimbursement for a car rental, on his trip to Mexico), Kozak, \$383. I also (perhaps in a second letter, I think, May 4) asked for payment of \$51.60 to Blissenbach, \$51.60 to Galindo Pohl, \$30 to Sidney Holt, \$54 to Douglas Johnston, \$56.16 to George Kent. Did you get that? Did they get paid?

The second matter: We still owe Jacques Piccard 1900 Swiss Francs for his trip to Mexico several years ago. At that time that was only about \$500. Today, of course, it is a lot more. I won't pay him the full 1900 Francs now in dollars, but he should get at least the 500. I am enclosing a check for IOI. Could you pay him?





I suspect that matters are coming to a head here. I have discussed the position with Jeff Kesteven, and I shall be able to talk to him and to Sidney when the latter comes here next week. I do have a problem which requires urgent solving somehow. It is the old question of settling the bills for the printing of PIM I. \$5 270 are still outstanding. In addition there is a further bill for \$1 118 for other work (including PIM III). Not so long ago you said I could use a thousand dollars to make a payment on account but this was in connection with the money from Mexico which you later told me was earmarked so I have not made that payment.

After my meeting with Jeff and Sidney we should be in a position to write to you a little more clearly about the future of IOI here. This letter is simply a warning (or should I say a plea) that it may be necessary to settle these bills at very short notice. I am sorry to be bothering you with these problems at a time when I know you have your own; I can assure you I would not have done it if I did not feel as worried as I do.



In the meantime you have obviously received the \$7500 from FIOI plus another \$1000 from Switzerland plus \$100 from the Friends, and today I am enclosing \$3000 from Mexico, together with a copy of our agreement. Please do not be alarmed by the contribution of \$15,000 charged to the IOI on this project. This is a contribution in kind, not in currency.

I assume that in the meantime you have been able to pay Madame Ringeard. I know that Mr. Kozak and Mr. Van Ettinger have received their money and I assume that Geoffrey Kesteven has been paid as well.

As to the Okinawa meeting, as I told you, the Marine Midland Bank has been paid off completely and so has been Mr. Landshoff. The interest $(8\ 1/2\%)$ had been paid currently by me.

I am glad that things with Geoff Kesteven seem to have worked out and I am enclosing a letter in which he proposes a budget which seems to me very reasonable.

As for Peter Dohrn, yes, he will have to wait until we are somewhat more affluent.

I have one item of good news. It seems, although it is not yet confirmed, that we are going to get a \$90,000 grant payable over three years for the Yearbook from the Edna McConnell Clark Foundation. It also seems that we will get \$30,000 payable over three years from the Government of Bahrain. Other things are pending.

With Geoff in Malta the Institute should get itself more into the public eye.

The Law of the Sea Conference was not quite as bad as might have been feared. Malta suffered a rather severe defeat in competing with Jamaica as possible host for the next Session of the Conference. It was a defeat that easily could have been avoided.

At the same time, however, I should like to ask you kindly to pay \$958 to Professor Roger Charlier, Northeastern Illinois University, Bryn Mawr at St. Louis Avenue, Chicago, Illinois 60625. This is a refund since something went wrong with the ticket sent from Algiers. I followed the matter up after the meeting in Algiers and was assured that at least the Algiers/Brussels part would be refunded by Alfiers but that money never came through. So I think the best way is to close the matter in the way here suggested.

Dear Edwin:

I am back from my peregrinations -- and ready to leave for the next one, to New York, for the L.o.S. Conference.

Jean showed me your letter of May 6. Let me answer point for point.

Glad you received the \$7,500 and that all payments have been taken care of. Wendel Mordy has not yet delivered his MS; hence no payment was due.

The \$3,000 from Mexico will come in due time. This is indeed an overhead on a grant that has been signed and sealed, and this amoung comes to you in accordance with the last paragraph of your letter. You can dispose of it in any way you think fit. We are having a working session with the Mexicans in June in New York, and will hasten the transfer of this amount.

As to the typescript of PIM VII, sorry to have caused inconvenience. Please return it to me to New York (c/o Permanent Mission of Austria to the United Nations, United Nations Plaza 809, New York, N.Y. 10017) and I'll try to get at least enough copies for the Delegations to the LoS Conference. The Algerians did not print our proceedings. They included a short piece in their proceedings -- but that was all we could obtain.

The proceedings of PIM VI instead have been printed lavishly in Japan. Copies are on their way: to the IOI, to us here, and to all delegations to the LoS Conference. That is very nice but, of course, the Japanese were far less lavish than the Algerians with regard to the Conference itselt!

Sorry you won't come to New York. You should not put it the way you are putting it and should come anyway: not "at my expense" but charging it to funds which are earned in order to be provided for this purpose. That is quite another matter. The meeting will be quite important.

That takes care of the points raised in your letter. Additional points:

You do not mention whether you wrote to Pronk about those \$10,000, or whether you have received them in the meantime. I wrote to him recently again, as per enclosed letter.

We received another \$10,000 grant from the Gulbenkian Foundation: \$5,000 will be paid immediately to your account; another \$5,000 before the end of the year. This is for the Yearbook.

I am now negotiating a grant from the Japan Trade Association, also for the Yearbook. This, however, should be paid to Santa Barbara as we have to pay bills here.

We have not yet heard from the Bank of Sweden; a lot of other fund raising activities are in course.

The money for PIM IX (1978) seems to be assured in Japan, and I am enclosing some pertinent documents. PIM VIII, instead, is still up in the air. I am exploring the possibility of getting it funded in the U.S. and of holding it in conjunction with the publication of the Yearbook in December or January. All this will be discussed at the Council meeting.

By the way, I had Victor Gauci a few copies of Oceans before he left for Malta.





Thank you for your two letters of the 9th and the letter of the 17th February.

As requested by you I have endorsed the cheque for \$17,000 in the name of Dr F.H. Landshoff and forwarded it to him in New York. I am enclosing a copy of the covering note. I still have not received the \$7,500 from FIOI, nor have I received the \$3,000 from Mexico. I have received instead a bill from Mme G. Ringeard for French francs 9,900 which in the circumstances I am not in a position to settle. Nor can I settle the bill for \$2,000 due to Dr van Ettinger. The same fate has to befall the \$1,500 due to Mr Aaron Kozak and the \$210 to Jeff Kesteven.

If you can hurry FIOI, and the Mexicans, to send the money I will settle these bills immediately.

Returning to the Okinawa meeting: I now take it that of the \$40,000 which were paid out of advance royalties for the Ocean Yearbook \$17,000 have been paid directly by you to Harry Abrams and \$17,000 have now been paid to Landshoff using the cheque from FIOI - leaving outstanding \$3,000 due to the Midland Marine Bank and \$3,000 to Landshoff (plus interests, of which I would like to know details).

I had hoped that Jeff Kesteven would come for a few days but he hasn't so far. Incidentally I have not settled the bill that I have received from Peter Dohrn for the film which he left at Algiers: I take it it is not your intention to give this matter any priority. Frankly I cannot see how Peter can expect us to pay for what was in effect simply one of his whims.

Things are quiet at the moment - possibly too quiet where the IOI is concerned. My worries about its future, which I expressed to you when you were last here, are still there; you will need to take the opportunity of your next visit here to try to resolve them one way or the other by direct contact with the PM. I suspect that with the present stricture on the finances of the University there is quite a possibility that the little financial help that the IOI gets might yet disappear.

Dear Edwin:

Thank you for your letter of January 27. I hope you have now safely returned from a fruitful trip.

Sorry there are so very many complications. But I trust that with this letter things will finally get settled.

You ask me for a complete account of the expenses and revenue regarding Okinawa and all particulars of the loans still due.

The accounts were sent to you, together with the full documentation, on January 22, 1976. I am enclosing a copy of my letter.

The first item on payments we made states

"Advance royalties on Drama of the Oceans....\$40,000"

This is a bit concise. The way the advance was arranged was that the publishers, Mr. Harry Abrams and Mr. Fritz Landshoff made loans of \$20,000 each, which were to be repaid from the royalties. Harry Abrams guaranteed his part of the loan, which was made in my name at the Midland Marine Bank. Mr. Landshoff made the loan in his own name -- I don't even know from what bank -- and paid the amount for IOI to the Japan Airlines.

The money to repay these loans has accrued long since. If the contract for the <u>Drama</u> had been made with IOI, as originally planned, then all your concerns would be wholly justified. But now the royalties for the <u>Drama</u> are not the IOI's. They are mine, and I will contribute half of them to the FIOI, which is what I am allowed under the Internal Revenue Service regulations. These will come to you simply as a grant from FIOI.

We have annulled the check for \$17,000 previously sent to you by FIOI, which you had endorsed to the Midland Marine Bank. We are not asking you to pay this again. It would take too much time. It really has to be paid before I leave this country. Therefore I am paying it directly from my royalties: without passing through FIOI. This does not invalidate the accounts I sent you on January 22, 1976: except in sofar as now it is not "Advance royalties" but it is "royalties." There is one inconvenience that arises for me: I will have to pay income tax on these \$20,000 next year. But this inconvenience is less grave than having to protract this matter any longer.

We are, however, issuing another \$17,000 to the IOI today. This is to pay back the loan to Mr. Landshoff. To whom we then still owe a final payment of \$3,000, plus some interest. I would therefore ask you kindly to endorse this check "Pay to the order of Dr. Fritz H. Landshoff." and to mail it to him at Harry Abrams Co., 110 East 59th Street, New York, N.Y. 10022. Please accompany it with a letter stating that this is a partial repayment of his loan which he made, in the form of a \$20,000 check issued to Japan Airlines. You have a record of this payment on the big sheets provided by Japan Airlines, from which it clearly results that this money was spent on travel fares for participants in Pacem in Maribus VI in Okinawa.

I hope this is all clear now. All the best, and looking forward to seeing you soon again.

Dear Elisabeth,

I am writing quickly in answer to your letter of the 20th January as I shall be leaving for London tomorrow. (I'll be back on the 10th February.)

The question of re-issuing a new cheque (for \$1500) and paying Mr Jan van Ettinger \$2000 for the printing bill is not as straightforward as you seem to think. I'll try to explain:

- (a) The letter from Aaron Kozak, dated January 5, 1977 to Marine Midland Bank refers to a Loan Account in your name with No. 406961. By inference the loan is for \$20,000. In your letter you give quite a different account number: 10-735468-3, and then 40152. I must have a document presumably from the Bank itself, giving the precise reference, and a clear indication that the loan was in connection with the Okinawa meeting. In fact it would be best if you did what I asked for recently, i.e. send me a complete account of the expenses and revenue regarding Okinawa and all particulars of the loans still due.
- (b) I still do not see why it is necessary to deposit the cheque here when all I need do is to change the endorsement and send a covering note to the bank. The \$2000 to van Ettinger might be dealt with on my receipt of a further \$2000 from FIOI, which in any case are due soon to pay the remaining part of the Okinawa loan.
- (c) If I split the cheque into \$15000 + \$2000 the payment to van Ettinger will not be covered by the Exchange Control Clearance. No such clearance is required if I received a separate cheque for \$2000. The whole exercise was in fact to avoid depositing the \$17000 cheque in the local account.

Please clear these points and in particular (a) so that I can deal with the matter immediately on my return.

I'm returning the cheque in case it is easier for Kozak to split it into \$15000 and \$2000.

I applied this amount to repaying advances from Joe Thomson, Sam Scranton, and James Laughlin, adding \$149.57 myself. Thus the account for travel expenses balances, and there are no debts.



I have just received your letter of the 17th December, 1976 enclosing the invoice for DFL 5366 in connection with the reprinting of the revised IOI Occasional Paper 5. (I am returning the invoice herewith; I have kept a copy.)

You have asked me to pay this 'from the \$2000 (you) sent together with the \$15000 from the FRIENDS'. There must be some misunderstanding: I have received one cheque from Kozak for \$17000 which he asked me to endorse in favour of the Marine Midland Bank and indicating that this amount would reduce the note the Bank has on the IOI. I have endorsed that cheque and returned it immediately. I am therefore not in a position to pay the RIO bill.

If there has been a mistake please ask Kozak to rectify it when he sends his next cheque. Your statement about the \$2000 implies that the Friends had intended that sum to be used for the ordinary running of the IOI and I think it would not be proper for it to repay the Okinawa debt.

Incidentally I should like to have a statement about the precise amount involved in that debt, and also a statement from your publishers regarding the amounts prepaid or due on the 'Drama'. I would like to have the present obscure position clarified as I simply do not have any idea of how we stand. All I can say is that our financial situation here, though not desperate, is certainly not easy; and I should like to be in a position to judge what the chances are of getting Kesteven to use the IOI as a base for his future 'operations'.

I paid the telephone bill you sent me - that used up an appreciable part of our bank balance. Also, do you realize that the present bill for 200 copies of your RIO paper is for an amount equal to nearly one-third of what PIM I cost - for 2000 copies! That bill is still part of my worries! I wish

I had both your ability to make money, and your flair for spending it seemingly without worry - I'm sure I'd live less anxiously than I do now!

But enough of this grumbling - and let me wish you a happy New Year. I shall be here - certainly for the first three weeks of January. I may leave during the last week for a meeting in London.

Much as we tried -- we failed in getting you here for the meeting. We missed you. It was, nevertheless, one of our best meetings, both of the Council and the Board.

You will receive a draft of the minutes in 10 days or so. In the meantime, here is the much overdue contract with various appendices.

Some explanations are necessary:

First of all, the Board of Trustees voted unanimously to authorize you to make the necessary assignments. This will appear in the minutes of the meeting.

Enclosed herewith you will find:

- l. The contract ("agreement") between the Institute and Harry Abrams. In three copies. This should be signed by you and returned to "r. Fritz Landshoff, Harry Abrams Co., 110 East 59th Street, New York City, N.Y. 10022. Please return all three copies. One will then be returned to you, for your file. Please note that on p. 7 of the agreement, a paragraph has been canceled. Because we did not set up a board of this kind; and Harry Abrams did by no means insist. The experts listed in this paragraph (or most of them) have indeed read the MS, given their advice and criticism, and they are in fact listed in the page of acknowledgments in the book. But in the form outlined under this paragraph, this agreement is obsolete and to be canceled. Please initial the cancellation on the margin.
- 2. The "Security Agreement." This concerns ♥20,000 of the advance I took to pay for Pacem in Maribus VI. As soon as this is signed, Harry Abrams will pay this obligation (the

money is in hand already), and this agreement will lapse. Please sign and return, to Dr. Landshoff, as above.

3. Letter concerning indebtedness to Mr. Landshoff. This was the other half of the advance I took for Okinawa. The money has already been earned, but will be accounted for only in September, at which time the debt will be paid (only receipts prior to December 31, 1975 can be used now for payments).

Everything beyond and above these advances is yours.

4. Assignment and Assumption Agreement. This is the assignment to the Friends. Please sign and return.

I would be grateful if you could take care of this right away. It has taken an absurdly long time to set it all up — and in the meantime, we are paying interest on the advances for Okinawa. Not two thousand dollars (there will be an adjustment at the end), but, certainly we don't want to pay more than necessary.

Of other things: the project for the OBEAN YEARBOOK was received very favorably by the meeting. I think it might do a lot, for the world and for IOI. I think I mentioned to you that SIPRI has agreed to furnish the part on military uses of the oceans to us on a yearly basis, free of charge; now I also have secured a commercial ppublisher, McGraw Hill, who will assume costs for production and distribution — and pay us a royal ty. On this basis, it should be relatively easy to raise the rest of the needed funds — which I shall endeavor to do this Spring. The production of the Yearbook will give an excellent framework to the activities of the Institute and its research projects, beyond the end of the Law of the Sea Conference: "e are entering a new phase of our work, and I think the Yearbook will provide an excellent focus for this new phase.


