

Gentlemen: I am enclosing my check for \$294.91 To settle this month's accounts. These have been computed as follows:

- 1. Last month's balance was covered on November 10 with my check No.7038 for \$466.09.
- 2. In accordance with our telephone conversation, I have divided the Pan Am charge of \$1,886.00 into twelve instalments, adding 12 percent, or \$226.42, which brings it up to \$2,112.32. Dividing this by 12, I get \$176.02 which is included in the present payment.

Dear Mr. Mathis:

I am enclosing my check for \$792.42. This means, I have deducted \$1,327.00, charged by Pan Am, \$38.02, charged by TWA, and \$156.27, charged by United Airlines, from the total amount of 2,313.71 shown on my statement.

These three charges need careful checking before I can pay them. They must go back to last December, at which time Pan American, TWA, and United made a colossal confusion with regard to an overseas ticket for which they first overcharged, and then overcredited me. They should be asked to fully document these charges. If and when the correct amount is established, this should be devided into twelve instalments, as I had originally requested.

I don't know whether you handle this with them or whether I have to handle it directly. If so please let me know, and I will take it up on my return to the States next month.
